Serves as a liaison/communication with the Resort, MAWSA (water/plume), township (dumpsters), road commission and all other associations. The SMPOA president sits on the President's Council with the resort and all other association Presidents at Shanty Creek. Reviews and negotiates contracts for snow removal and grass maintenance. Provides snow removal on all secondary roads and around fire hydrants. Lawn mowing on all primary and secondary roads. Planting of flowers, maintenance and lighting of 5 Corners and sign post gardens. Removal of limbs and trees throughout the year. Annual brush pick up/chipping. Repair/replacement of street signs. Pool passes for each family and maintenance of the website.
